Veeco's implementation of Sign In Solutions enabled personalized sign-in experiences for different visitor categories. The system includes ID scanning and visitor photo capture, host notifications via SMS, and automated welcome emails with WiFi credentials.

The platform's flexibility allowed Veeco to add state-required forms and evacuation information to their check-in process for each location remotely, without the need to visit individual sites.

## Adapting to health and security needs

During the COVID-19 pandemic, Veeco quickly integrated health screening questions into their visitor sign-in process. Visitors answered COVID-19 screening questions before entry, and if a concern was flagged, an alert was sent to Roger.

The new system also conducts background checks, screening visitors against restricted lists to maintain security compliance.

## Managing security and compliance requirements

Because Veeco handles sensitive materials, they must comply with Department of Transportation security regulations. Sign In Solutions' visitor management system screens visitors against multiple compliance watchlists, including Export Restricted & Denied Persons Lists, Sanctioned Entities & Blocked Persons Lists, and International Terrorist Watchlists.

"If any of the data matches a restricted list, it triggers an alert. It's instant and effective." When an alert is triggered, entry is denied, giving Veeco immediate security protection."
